1. Alcorn, Ellenor M. **English Silver in the Museum of Fine Arts, Boston. Volume 1- Silver before 1697.** *Boston; MFA / Northeastern University Press: 1993.* The MFA's tradition of producing elegant catalogs continues with this effort, which illustrates part of the MFA's collection of early English silver, recognized as one of the finest in the world. The catalog features extremely fine photography, and extensive and scholarly entries which fully describe and discuss each piece. Many of these pieces had not previously been published elsewhere. Andrews, Gail C., et al. **Silver from the Collection of the Birmingham Museum of Art.** *Birmingham, Alabama; Birmingham Museum of Art: 1982.* A nicely written and photographed catalog of selections from this collection. Most of the pieces are 18th-early 19th century English, with some American and Irish examples as well. Softcover. 8"x10", 81 pages, b/w illustrations. Minor wear, corner bump. [39460] \$25
3. **Antique Silver Exhibit.** *The catalog to an exhibition sponsored by the Washington College Chorus in 1968.* A short catalog of 226 pieces of American and English silver lent from a number of private collections and several churches. The descriptions are short. Softcover. 5.5"x8.5", 19 pages. Minor soil. [41946] \$20
4. **Antwerps Huiszilver uit de 17e en 18e Eeuw (Rubenshuis) / Zilver uit de Gouden Eeuw van Antwerpen.** A pair of exhibition catalogs chronicling three centuries of Antwerp silver. The catalog of the exhibition at the Rockoxhuis Museum features work of the Dutch "Golden Age" of the 16th century, and the catalog of the exhibition at the Rubens House Museum features 17th and 18th century work. Both catalogs features introductory essays and extensive catalogs of the pieces in the exhibitions, with many marks illustrated. Dutch text. 2 volumes. 5. Arkwright, D.L. & B.W. Bourne. **Church Plate of the Archdeaconry of Ludlow, Diocese of Hereford.** *Shrewsbury; W.B. Walker: 1961.* The theft of an antique chalice from a Shropshire church brought attention to the fact that there was no useful inventory or description of the antique plate in the entire Archdeaconry. Though the chalice was eventually recovered it was thought prudent to conduct the inventory of which this useful book is the result. Softcover. 7"x9.5", 67 pages plus 3 black & white plates. 6. Atterbury, Paul (ed.). **A.W.N. Pugin. Master of Gothic Revival.** *Published for the Bard Graduate Center for Studies in the Decorative Arts by Yale University Press in 1995.* A.W.N. Pugin was one of the most influential designers and architects in the 19th century. As a collector and scholar he pioneered a new appreciation for Medieval art and architecture; as an architect he created cathedrals, churches colleges and a wide variety of buildings whose design profoundly

influenced architectural design in the Victorian era; as a designer he established Gothic as the Official Style of Great Britain and one of the most popular decorative forms to emerge in the nineteenth century. This massive catalog, which accompanied an equally massive loan exhibition, is packed with illustrations and features essays by Megan Aldrich, Paul Atterbury, and many others. 7. Ball, A. William. **William Ball, The Philadelphia Silversmith and some notes about the Baltimore silversmith, Wm. Ball.** *Published by the author: 1993.* A collection of notes about Philadelphia silversmith William Ball [1729-1810], who also made pewter, with examples of his silver and a close study of his hallmarks. Very uncommon. Softcover. 6"x9", 22 pages, black & white illustrations. Minor wear. [36977] \$40

8. Barquist, David L., et al. **Myer Myers. Jewish Silversmith in Colonial New York.** *New Haven; Yale University Art Gallery: 2001.* Born in New York in 1723, Myer Myers became the city's leading silversmith during the late colonial period, and is now remembered as one of America's great craftsmen. This catalogue explores his career in the larger contexts of the Jewish community, the silversmith's trade, and his network of patrons. Large-scale color photographs of his teapots, tankards, milk pots, and candlesticks are presented alongside maps, paintings, and other illuminating documents. An appendix focuses on the nine signature marks that Myers employed, and an extensive bibliography is provided. Hardcover. 9.5"x11.5", 304 pages, color and b/w illustrations, dust jacket. Minor wear. 9. Barradas, Jose Perez de. **Orfebreria Prehispanica de Colombia.** *Madrid; Banco de Republica (Bogota): 1954.* A splendid study of Prehispanic goldwork of the Calima style (named for the Calima River) in Columbia. In subsequent years four more volumes on other styles would be published. 2 volumes. Hardcover. 9.5"x12.5". Volume 1- xvi + 367 pages, with 20 color plates and 201 black & white illustrations. Volume 2- 19 pages plus 300 black & white plates. Dust jackets. Jackets a bit worn. [35582] \$100

10. Becatti, Giovanni. **Oreficerie Antiche dalle Minoiche alle Barbariche.** *Published by the Istituto Poligrafico dello State in Rome in 1955.* A scholarly study of antique jewelry from the Minoan Period. The author, Giovanni Becatti (1912–1973), "was an Italian Classical art historian and archaeologist. Born at Siena, Becatti was educated at the University of Rome under Giulio Quirino Giglioli. Becatti was appointed to the Superintendency of Ostia in 1938. He was professor of Archeology and History of Classical Art at the University of Pisa (1941–1944) and at the University La Sapienza of Rome (1945–1946). From 1947 to 1950, he was Director of the excavations of Ostia Antica. Then Becatti moved to chair the department at the University of Milan from 1952 to 1956, in Florence from 1957 to 1964 and the University of Rome from 1964 to his premature death in 1973. Becatti continued to publish on and excavate Ostia throughout his career. He altered his publishing interests from Etruscan subjects to Ancient Greek and Roman Art. He was the editor of the prestigious Enciclopedia dell'Arte Antica (1958–1966), with and after Bianchi Bandinelli. He was member of the Accademia Nazionale dei Lincei, of the

Pontificia Accademia romana di Archeologia, of the Accademia della Arti del Disegno, of the Istituto di Studi etruschi e di Studi romani" (Wikipedia). With the bookplate of H. Dunscombe Colt (Harris Dunscombe Colt, 1901-1973). Find a Grave notes- "Archeologist and R. Kipling documents collector. The focus of his career was on archaeology: he worked in Egypt under the noted British Egyptologist, W. M. Flinders Petrie, and took part in excavations in Malta. For four years in the thirties, he directed his own archaeological "dig" at Auja el Hafir in the Negev. He inherited a love of collecting from his father, who had assembled a fine series of historical views of New York City, and from this grew his own unfinished work on an encyclopedia of all prints and engravings by American artists up to about the year 1880. In addition, he was a collector of coins and had made a notable collection of Kipling first editions". 11. Beckman, Elizabeth D. **Cincinnati Silversmiths. An In-depth Study of the Cincinnati Silversmiths, Jewelers, Watch and Clockmakers through 1850. Also Listing the More Prominent Men in These Trades from 1851 until 1900.** *Cincinnati: B. B. & Co.: 1975.* An important study of Cincinnati silver and silversmiths, based on a great deal of original research by the author. The book also includes extensive excerpts from the diary of silversmith Jacob Deterly from 1819 to 1833. Robert Alan Green wrote the laudatory Foreword. Berthod, Bernard & Elisabeth Hardouin-Fugier. **Dictionnaire des Arts Liturgiques, XIXe-XXe Siecle.** *Paris; Les Editions de l'Amateur: 1996.* A very important (and now very scarce) dictionary of terms, objects, vestments, decorations, designers, craftsmen, architects and everything else to do with liturgical arts & crafts and ceremony in 19th and 20th century France. Well illustrated, comprehensive, and very heavy. Marks of silver and goldsmiths are shown. Hardcover. 9.5"x12.5", 463 pages, color and black & white illustrations, dust jacket. Fine. [37291] \$350

13. [Biggs] **The Biggs Collection of Early Spoons.** *London; Christie, Manson & Woods: September 20, 1978.* Anna Rupert Biggs was the daughter of Charles Rupert, author of the book 'Apostle Spoons'. Her collection contained a fine selection of London and other English spoons of the 16th and 17th centuries. A very uncommon catalog. Softcover. 6"x9.5", 93 lots, 30 pages + 26 black & white plates. Bimbenet-Privat, Michele. **Les Orfevres Parisiens de la Renaissance (1506-1620).** *Paris; Commission des travaux historiques de la Ville de Paris: 1992.* The definitive study of Renaissance silversmiths in Paris, with discussion of the period, trade, patrons, 200 pages of silversmith listings, and many illustrations and descriptions of the silver itself. An impressive and important reference work. Hardcover. 8.5"x11", 691 pages, many black & white and some color illustrations, slipcased. Minor wear. [36745] \$125

15. Binder, Deborah. **St. Louis Silversmiths.** *Saint Louis Art Museum: 1980.* The catalog to a loan exhibition which included both antique and modern silver. There is an essay on St. Louis silversmiths, as well as short descriptions of each item, with thumbnail notes on the silversmiths. Softcover. 7"x11", 40 pages, b/w illustrations. Light wear. Bliss, Joseph R. **The Jerome and Rita Gans Collection of English Silver on Loan to the Virginia Museum of Fine Arts.** *New York; ARN Publishing: 1992.* A finely-illustrated catalog of 82 examples of English 17th, 18th and early 19th century silver from this noted collection which was then on permanent loan to the museum. Boughton, Peter. **Catalogue of Silver in the Grosvenor Museum, Chester.** *Chichester; Phillimore: 2000.* The Grosvenor Museum's silver has been described by Country Life as 'one of the country's finest collections'. Its greatest strength is Chester hallmarked, between c.1570 and 1992, spanning a wide range of uses. After the collection's growth is set in the historical context of the developing scholarship of the subject, each piece is illustrated, described in detail and with a full background of the design evolution, its maker and ownership. An essential work of reference for all collectors and a rich source for students of the decorative arts and history of silver. 20. Bowen, John R. & Conor O'Brien. **Cork Silver and Gold. Four Centuries of Craftsmanship.** *The Collins Press: 2005.* The first full study of cork silver and silversmiths, based on an exhibition at Cork's Crawford Gallery. The book includes photographs and descriptions of many examples, as well as a history of silversmithing in Cork, a directory of Cork silversmiths, and marks. 21. Boylan, Leona Davis. **Spanish Colonial Silver.** *Santa Fe; Museum of New Mexico Press: 1974.* A well illustrated study of New Mexican colonial Spanish silver which argues that New Mexican colonial silver had stylistic characteristics which differentiated it from other Spanish colonial silver. Based on silver collections in five New Mexican museums, this study includes chapters on the collections, the historical background, ecclesiastical silver, domestic silver, "accessories and gear", and provincial styles, as well as an extensive photographic mark section and a good bibliography. 22. Bradbury, Frederick. **History of Old Sheffield Plate, Being an Account of the Origin, Growth and Decay of the Industry and of the Antique Silver and White or Britannia Metal Trade with chronological lists of makers' marks and numerous illustrations of specimens.** *London; Macmillan and Company: 1912.* Nearly a hundred years after its first publication, this book remains the standard reference on the famed Sheffield plating firms of England and their wares. Himself a Freeman in the Worshipful Company of Cutlers, Bradbury brought personal knowledge of the silver manufacturing industry to his writing, and spent years researching the origins and history of the Sheffield trade in dusty record rooms and little-used archives. He covers the invention and early manufacture of Sheffield Plate, the history of the Trade, its "processes, practices and inventions", the workshops, tools & materials, and innovations, as well as offering advice to collectors, notes on the dating of specimens, and lists of makers and their marks. Braham, Helen. **A Century of Silver: The Courtauld Family of Silversmiths, 1710-1780.** *London; Courtauld Institute Gallery: 2003.* "A remarkable collection of 18th century silver, made by three generations of Courtauld family silversmiths. The Courtauld silver collection, unique of its kind, comprises pieces by three generations of 18th-century London silversmiths, members of the Huguenot Courtauld family and ancestors of Samuel Courtauld, after whom the Courtauld Institute of Art is named. Designed for domestic use and display, the items range in date from 1710 to 1779 and demonstrate the quality of workmanship and innovative design skills brought to England by Huguenot refugee craftsmen. The silver described in this book represents a unique selection of typical and rare pieces from the finest period of London silver-making, illustrating the development of style in the eighteenth century from Queen Anne to Rococo and early Neoclassicism. There are chapters on the Courtauld family; the making and marketing of silver; silver for the new hot drinks (tea, coffee, chocolate), for candlesticks and correspondence, for dining and display; and on early Huguenot silver." 24. **Britannia & Muscovy English Silver at the Court of the Tsars.** *Yale Center for British Art: 2006.* A small handbook which accompanied the exhibition of British diplomatic silver sent to Russia in the 16th and 17th centuries. Gives a general overview of the topic, rather than discussing and illustrating specific items. Softcover. 5"x7", 29 pages, 6 black & white illustrations. Fine. [32701] \$10

25. Brosens, Koenraad & Leo De Ren. **Ruimte voor zilver.** *Antwerp; Provinciaal Museum Sterckshof - Zilvercentrum: 2000.* A catalog which presents a wide variety of silver from the Museum's collection in a "modern", accessible, unhurried way, as is explained in the Introductory notes. Not a catalog of superlatives, but a more modest examination of the collection as a whole, with some whimsical asides. Interesting. Dutch/French/English text. 26. Buck, John H. & R.T.H. Halsey. **American Silver, the Work of Seventeenth and Eighteenth Century Silversmiths.** *Concord; Joslin Hall: 1990.* A facsimile reprint of the catalog to the historic 1906 exhibition. This exhibition was the first to be devoted exclusively to the work of American silversmiths and was of great importance in generating interest in the work of American Colonial silversmiths. It also provided valuable information to scholars and early collectors, and the enthusiasm that it generated was in large part responsible for several important subsequent exhibitions. But more than that, it began the tradition of elegant design for silver catalogs. Engraved designs are reproduced, and inscriptions are set in italic type. Buhler, Kathryn C. **Colonial Silversmiths -Masters & Apprentices.** *Boston; Museum of Fine Arts: 1956.* A loan exhibition which explored the relationship between the work of master silversmiths and their apprentices using surviving examples and records. 30. Buhler, Kathryn, et al. **A Century of Alexandria, District of Columbia & Georgetown Silver, 1750-1850.** *Washington; Corcoran Gallery of Art: 1966. Limited to 1500 copies.* A loan exhibition drawing on private and public collections. The works of 13 silversmiths are represented, and there is an additional list of other area silversmiths who have been identified. 31. Buhler, Kathryn C. **Masterpieces of American Silver.** *Richmond; The Virginia Museum of Fine Arts: 1960.* The catalog to an important loan exhibition which drew pieces from numerous public and private collections and focused on southern silver, a much-neglected area at the time. There are important and interesting essays by Kathryn Buhler titled- "The Hand Craft Era in American Silver", "Important (silversmithing) Centers", "Techniques of the Craft", and "Types (of silver) and Their Uses". Burschel, Carlo & Heinz Scheiffele. **WMF Ikora Metalwork from the 1920s to the 1960s / WMF Ikora Metall 1920er bis 1960er Jahre.** *Stuttgart; Arnoldsche: 2006.* This publication draws on sales catalogues and advertising brochures documenting the entire range of Ikora metalwork produced by WMF (Wårtttembergische Metallwarenfabrik AG, Geislingen) from the early 1920s until the 1960s. Even during the first world war, Hugo Debach, who would later become director-general of WMF, took the initiative in having experiments conducted in chemical and thermal tinting of metals. Shortly before 1927 he founded the Neue Kunstgewerbliche Abteilung (NKA: New Division for the Applied Arts) at WMF for upgrading metals. The brilliant colours and the boundless possibilities for design arising from this new technique met with resounding success at the time. 33. Bury, Shirley. **Copy or Creation. Victorian Treasures from English Churches.** *London; Worshipful Company of Goldsmiths & the Victorian Society: 1967.* The catalog to an interesting loan exhibition of Victorian ecclesiastical silver, much of which was created in Revivalist styles mimicking earlier periods in silversmithing history. The text includes a Foreword by John Betjeman, Vice-Chairman of the Victorian Society, and an essay by Shirley Bury of the Victoria & Albert Museum. Sanchez. **Los Arfes, Escultores de Plata y Oro (1501-1603).** *Madrid; Editorial Saturnino Calleja: 1920.* The life and work of a famous Spanish silversmithing family of the 16th century- Enrique de Arfe, Antonio de Arfe, and Juan de Arfe. Softcover. 4"x6.5", 79 pages + 28 b/w plates; publisher's decorated covers with a Renaissance frame of pillars and putti; covers lightly spotted; contents with light foxing throughout; partially unopened. Carnegie, Moir. **Church Plate in the Hundred of Blackheath.** *London; The Blackheath Press: 1939.* A survey of 17th, 18th, and early 19th century church silver of the area of Kent known as the Hundred of Blackheath which includes the parishes of St. Nicholas, Deptford; St. Paul, Deptford; St. Alfege, Greenwich; the Royal Hospital at Greenwich; St. Luke, Charlton; St. Mary, Woolwich; St. John, Eltham; St. Mary, Lewisham; The Ascension, Blackheath; St. Margaret, Lee; Morden College, Blackheath. 37. Cederwall, Sandraline, Hal Riney & Barnaby Conrad. **Spratling Silver.** *San Francisco; Chronicle Books: 2000.* A revised, expanded edition of this oversize, wonderfully-illustrated book. A dramatic tribute to the works of William Spratling, a world-renowned artisan in silver. Spratling's designs for tableware, flatware, jewelry and other silver objects have left an indelible stamp on the history of 20th century silversmithing. Illustrated with more than 70 full-page plates. The marks for each piece are illustrated. Hardcover. 9.5"x12", 176 pages, many full-page color plates, dj. Minor wear. [36566] \$45
38. Christie, Ralph Aldrich. **Silver Cups of Colonial Middletown.** *Middletown; Middlesex County Historical Society: 1937.* A rather scarce study of the Middletown Communion silver. Christie's charming and informative text wanders all around his subject, taking on, in turn, the life of the typical silversmith in a colonial Connecticut town, the churches, pastors and donors of the silver, and the silversmiths themselves, who included Joseph Kneeland and Jacob Hurd of Boston, Major Jonathan Otis of Middletown, and John Dixwell, Jr. of Middletown and Boston. Dixwell's father had, as Colonel John Dixwell, been among the judges who had signed Charles I death warrant and had fled England at the Restoration, ending up in Middletown. Such interesting anecdotes fill this book, which gives the reader insight into the role Communion silver played in Colonial America and how one town acquired it. Club members were so pleased that they then voted to forgo flowers and table decorations at future dinners, and to put the unused \$100 per dinner aside in a fund to pay for the silver. Additional pieces were donated from time to time, and by 1932 the Farmers had 16 fine pieces or sets, a mix of new and antique, including the pair of new candelabra by Dominick and Haff, a 1793 London flagon, a 1748 London tankard, an 1833 London waiter, an 1809 tureen by William Eley, several 19th century loving cups, a 1780 Newcastle goblet, and a set of 66 dinner plates made in London in 1773, 1800 and 1801. The story of the dinner plates is especially interesting- 48 of them were placed at the table for a December 20th, 1927 dinner, and it was announced that these plates had been presented by the King of England to the House of Commons in 1801. The estate of the Speaker of the House at that time had come up for sale and the plates were purchased in memory of former members of the Farmers, now deceased, and each plate would be inscribed in memory of a member, to be donated and paid for by a current member. Eighteen additional plates were later purchased and also donated. Built in the first century B.C., and named after a well-preserved fresco of the ancient Greek poet found there, little is known of the actual owner of the house, though it seems likely that he was either a wealthy Pompeian merchant, or perhaps a rich Roman who built a seaside villa in the popular resort town.

The author of this important study, Amedeo Maiuri [1886-1963], has been described as one of the most dynamic and controversial archeologists to oversee the excavations in Pompeii. He was one of the first to employ a rigorously systematic and scientific approach, instead of viewing the ruins as a treasure heap to be plundered; unfortunately many of his excavations suffered from under-funding and inadequate tools, and his legacy remains mixed. There is no controversy, however, about the importance of the silver hoard that was uncovered in the basement of the Casa del Menandro in 1930. "In the cellar, wrapped up in textiles and placed in the bottom of a wooden chest, were 118 pieces of silver plate, of varying ages and styles... a separate box placed on top of the silverware contained 20 pieces of jewellery made of gold and precious stones, along with some gold wire and 46 coins..." writes John Tamm in his review of the book "The Insula of the Menander at Pompeii. Vol. IV: The Silver Treasure" by Kenneth Painter (2001).

"As Painter rightly notes", Tamm continues, "the importance of this treasure lies not only in the artifacts, but also in the fact that they were properly excavated, a statement that cannot be made for the other major find from the area, the Boscoreale treasure. ...Just as this treasure has long been of prime importance for the Roman silverware specialist, so too has been Amedeo Maiuri's detailed publication, 'La Casa del Menandro e il suo tesoro di argenteria'. It will doubtless remain important, especially in light of its thorough art-historical discussions and copious illustrations, but a present-day reader, assuming s/he could even find a copy of the book, would have to treat it with caution. In light of subsequent research and changes in emphasis, various aspects of Maiuri's work need re-evaluation, if not thorough revision". When the silver collector Maurice Brix died, Phillips, who maintained a life-long interest in antique silver work, cataloged the unfinished inventory. He was also hired to research the decorative arts collection of Francis Garvan the same year. When the collection passed to Yale University, Phillips accompanied the collection, joining the faculty in the art department, as Assistant Curator of Silver (to 1933). Phillips developed the popular decorative arts course at Yale in 1932, known to students as "pots and pans." He was named acting director of the Yale University Art Gallery in 1941 and assistant professor of the history of art at around the same time. During World War II, Phillips served first in Army Counter Intelligence in Boston before reassignment to the Looted Art Investigation Unit of the Office of Strategic Services (OSS). There he worked with S. Lane Faison (q.v.) in England and then in the Netherlands. His major responsibility was to recover Dutch art stolen by the Nazis. While performing these duties, he noticed that a Vermeer repatriated from Herrmann Göring's collection, contained a depiction of a tankard from the nineteenth century. Suspecting a forgery, he assisted the Dutch authorities in exposing the master forger Han van Meegeren (1889-1947), whom he interviewed in prison. After returning from the war, Phillips was named permanent director of the Gallery and professor of the history of art at Yale in 1948. He was later named the curator of the Mabel Brady Garvan Collection of American Decorative Arts at the Gallery. While on a commuter train to New Haven from New York he suddenly became ill and died en route to the hospital at age 48. Later, Dr. Pleasants taught diagnosis to medical students at Hopkins until his retirement in 1934. His interests were varied and included education, historical research,

and fine arts. Pleasants served as a trustee for Johns Hopkins University, the Peabody Institute, the Baltimore Museum of Art, the Gilmor Country School, and the Peale Museum. He was the president of the Supervisors of City Charities in Baltimore from 1904-1921. As a member of the Maryland Historical Society since 1898, J. Hall had been the corresponding secretary and the vice president. He wrote several books including *The Curzon Family of New York and Baltimore*, (1919); *Maryland Silversmiths, 1715-1830*, (1930) with Howard Sill; *An Early Baltimore Negro Portrait Painter, Joshua Johnson*, (1939); and acted as editor of the *Archives of Maryland* series from 1929-44. When the silver collector Maurice Brix died, Phillips, who maintained a life-long interest in antique silver work, cataloged the unfinished inventory. He was also hired to research the decorative arts collection of Francis Garvan the same year. When the collection passed to Yale University, Phillips accompanied the collection, joining the faculty in the art department, as Assistant Curator of Silver (to 1933). Phillips developed the popular decorative arts course at Yale in 1932, known to students as "pots and pans." He was named acting director of the Yale University Art Gallery in 1941 and assistant professor of the history of art at around the same time. During World War II, Phillips served first in Army Counter Intelligence in Boston before reassignment to the Looted Art Investigation Unit of the Office of Strategic Services (OSS). There he worked with S. Lane Faison (q.v.) in England and then in the Netherlands. His major responsibility was to recover Dutch art stolen by the Nazis. While performing these duties, he noticed that a Vermeer repatriated from Herrmann Göring's collection, contained a depiction of a tankard from the nineteenth century. Suspecting a forgery, he assisted the Dutch authorities in exposing the master forger Han van Meegeren (1889-1947), whom he interviewed in prison. After returning from the war, Phillips was named permanent director of the Gallery and professor of the history of art at Yale in 1948. He was later named the curator of the Mabel Brady Garvan Collection of American Decorative Arts at the Gallery. While on a commuter train to New Haven from New York he suddenly became ill and died en route to the hospital at age 48. The box was originally but a simple horn box for a pocket, and was purchased at a fair by Overseer Henry Monck. Upon leaving office in 1713 he presented it to the Society, and its members, out of "respect to the donor, ornamented it with a silver rim, on which his named was engraved". Thus began a tradition that each departing overseer would add some silver ornament to the box when leaving office. Having run out of room on the original box, an additional case was soon added, and then another, and then another, and then... and on and on through the 18th century and into the 19th. In addition, it was tradition that the new ornamentation or case would contain a pictorial or word record of significant events of the years since the last overseer.

These scenes and ornaments were quite elaborate, not mere chased leaves. They included numerous interior scenes, portraits, architectural scenes, a depiction of the court scene when the box was held by a past overseer and the Society went to court to reclaim it, a full-blown scene of a British frigate defeating a French ship at sea, the Peace Proclamation of 1802, the China Fleet repulsing a French naval squadron, the Jubilee and Death of George III, the bombardment and capture of Algiers, a battlefield scene of the victory of Wellington at Waterloo, the interior of the House of Commons during the trial of Queen Caroline, and so on. The standard of engraving, both on the box and in this book, was quite high. Hardwick concludes- "The famous receptacle for the fragrant weed is not only the biggest in the world, but unquestionably an historical curiosity in the bargain".

Abrams: 1987.* A lavishly-illustrated book, the first in-depth study of American presentation silver, from the Colonial period to the 20th century. I tend to think of "presentation silver" as grandiose, elaborate pieces of the Victorian era, and there are plenty of those here, but there are also many interesting 18th
